

## Announcement of regulated information of L 3556/2007 Notification of significant changes in voting rights

The company ELLAKTOR S.A. informs about the notification of significant changes in voting rights, received on **December 7**<sup>th</sup>, **2020**, by a shareholder.

**REGGEBORGH INVEST B.V.** ELLAKTOR'S shareholder, in compliance with the Directive for transparency, informs that its participation and its voting rights in the share capital of ELLAKTOR SA changed accordingly:

a. On 27.11.2020, the participation and voting rights (total positions) as a result of a potential exercise of the Call Option (26,882,023 shares and voting rights of ELLAKTOR SA, which accounts for 12.5457% of the total voting rights in ELLAKTOR SA, with expiry date of the call option 180 days after 10.09.2020 and the exercise/conversion period between the 1st and 180th days after the September 10th 2020) may be increased and exceed the 20% threshold, in particular:
