

Announcement of regulated information of L 3556/2007 Notification of significant changes in voting rights

The company ELLAKTOR S.A. (the "Company") informs (art. 9 of L. 3556/2007), in compliance with the Directive for transparency, about the notification of significant changes in voting rights of the Company, received on **July 5th**, **2021**, by a shareholder.

REGGEBORGH INVEST B.V. informs about the notification of significant changes in voting rights as follows:

1. Date of transaction when its participation exceeded the 25% threshold: June 30th, 2021

Number of shares and number of voting rights before the transaction:

- a. direct participation: 24.294% (i.e. 52,054,773 common registered shares with voting rights) and
- b. indirect participation: 0% (i.e. 0 common registered shares with voting rights) and

<u>Total participation (directly and indirectly) and voting rights:</u> 24.294% (i.e. 52,054,773 common registered shares with voting rights) issued by ELLAKTOR SA.

Additional information

The purchase of 6,526,183 shares (6,071,183 on June 30^{th} and 455,000 on July 2^{nd}) was made via on exchange (block trade). The notifications were made due to the shareholder REGGEBORGH INVEST B.V. exceeding the threshold of 25% and change of 3%.

Also, REGGEBORGH INVEST B.V., during the option exercise period (between April 20th and July 20th, 2021) is entitled to direct the exercise of the voting rights attaching to the 6,828,260 call option shares

REGGEBORGH INVEST B.V. is not controlled by any natural person or legal entity in the sense of Art.3 of L.3556/2007 and does not control any other undertaking(s) holding directly or indirectly an interest in ELLAKTOR SA.
