## COOKIE USAGE NOTICE

This Cookie Policy explains what cookies are and how we use them on our Website. You should read this Policy in order to understand the types of cookies we use, the information we collect through cookies, and how such information is used.

### WHAT ARE COOKIES

Cookies are small text files containing information that are stored by a website's server on the terminal device (computer, mobile phone, etc.) of a visitor/user while browsing the website. The website retrieves this information on each visit in order to provide services related to such information.

A typical example of such information is the user's preferences on a website, as indicated by the choices they make (e.g. selection of specific "buttons", searches, etc.).

Cookies may be installed either by the provider of the website visited by the user (first-party cookies) or by third parties through the website provider (third-party cookies).

### USE OF COOKIES

We use cookies on our Website to provide you with the best possible browsing experience, as they make it easier for visitors to access and use our Website during future visits. Cookies also allow us to monitor Website traffic, enhance functionality, and tailor the content of our Website to its visitors.

### TYPES OF COOKIES WE USE

The website [www.ellaktor.com](http://www.ellaktor.com) uses: a) Functionality Cookies and b) Performance Cookies.

#### A. FUNCTIONALITY COOKIES

These cookies are necessary for browsing the Website and for purposes of internal security and system administration. The Functionality Cookies used on our Website include the following:

Name	Duration	Description	Type
stock_price	30 seconds	This cookie stores information related to the current share price displayed in the upper right corner of the web page allowing the price to be updated immediately during browsing. It is essential to provide users with accurate and up-to-date financial data.	functional
darkMode	30 days	This cookie stores the user's preference for activating the dark theme (dark mode) on the website, ensuring a more comfortable and personal browsing experience.	functional
wp-wpml_current_language	session	The cookie determines the user's currently selected language on the site, through the wpml plugin, allowing the content to be continuously presented in the selected language during browsing.	functional
addtl_consent	1 year	It records the choices the user has made in the cookie consent banner, allowing the application of their preferences regarding the acceptance or non-acceptance of cookies.	functional
euconsent-v2	1 year	Reflects the user's choices in the cookie consent banner in accordance with the e-Privacy Regulation and the GDPR contributing to the legal processing of personal data	functional
cookiesession1	30 days	This cookie contains a unique identifier (ID) associated with the user's current session. It is used to maintain the state of the user's communication with the website as they navigate from page to page, allowing for a consistent and secure experience. The information stored is temporary and is deleted after the end of the user's connection.	functional

## B. PERFORMANCE / TRAFFIC ANALYSIS COOKIES

Performance cookies collect information about the use of our Website and help us improve both its functionality and the provision of better user experience for visitors. They are used by the Website to transmit statistical information to Google Analytics, through which the Company is able to perform statistical analysis of access to and visits on the Website.

The Performance / Traffic Analysis Cookies used on our Website include the following:

_ga	2 years	This Google cookie is responsible for identifying unique users for performance statistics. Through this anonymous identifier, Google records users who return to the site and analyzes how they interact with the content, helping to improve the experience of all users.	performance
_ga_(id)	2 years	This Google cookie maintains the state of the user's connection and includes a unique identifier used to provide consistent browsing as well as to record the user's interaction with the website for the purpose of analyzing and improving services and content	performance

## MANAGEMENT AND DELETION OF COOKIES

Our website provides a consent and preference management mechanism regarding the use of Cookies ("Cookie Settings"). Strictly Necessary Cookies are mandatory and are enabled by default upon the visitor's entry to the website. You may delete and block non-essential cookies, however, certain parts of our website may not function properly without them. In addition to managing cookies through the

website, visitors may modify the settings of their browser or mobile device in order to prevent cookies from being installed on their computer or mobile device.
